2) LPWP membership

Update and wishes

The Chairman and all delegates express deep gratitude for their effective and long lasting contribution to LPWP as well as wishes for the future to retiring members: Adam Markowski (Poland) and André Laurent (France).

All members welcome new appointed delegates for the same Countries, respectively Agniezska Gajek and Laurent Perrin.

Current situation of delegates:

- Slovenia, Spain, Greece, UK each one open position
- No delegates of Austria, Bulgaria, Croatia, Denmark, Hungary, Romania, Russia, Turkey, Ukraine, etc.

An effort is required to find out new delegates, possibly from industry.

Referring to international guest members, delegates are invited to propose a new guest from China, as prof Wu Zongzhi did not reply to several invitations.

3) LP2019 Evaluation

GR presented updated numbers from LP2019:

- 419 participants
- 268 participants at the welcome reception c/o Porceleyne Fles
- 140 participants at the conference gala dinner (10 no-shows)
- 35 Countries Australia, Austria, Belgium, Brazil, Canada, China, Taiwan, Colombia, Czech Republic, Denmark, Finland, France, Germany, Greece, India, Italy, Japan, Kuwait, Libya, The Netherlands, Norway, Poland, Ireland, South Africa, Russian Federation, Saudi Arabia, Slovak Republic, Slovenia, Spain, Sweden, Switzerland, USA, UK.
- Most participants from the The Netherlands (106), Germany (68), Italy and Belgium (both 31).
- Attendance from Universities (71), Companies (229), Institutes/Ministries (119)

A roundtable discussion on LP2019 was performed.

Main points for future LP organization.

Excellent keynote speakers with 9 lectures representing an exception for LPS.

Good sessions but too many parallel sessions: maximum 4 to avoid confusing. Some sessions with few delegates.

Roundtables very interesting but it seems advisable avoiding different locations. Avoid having them at the end of the day.

Poster must be removed only at the end of the symposium: only poster present until the end will be considered for poster award. The winners of poster award must be present at the closing ceremony to receive the award.

Consider the options one chairman vs two chairmen. It can be better to have a co-chairman. Author self-presentation seems a better option.

Time for full presentation too long: better selection of full oral presentation and reduction in their number, so increasing short oral presentations.

Many attendees complained about program layout. Ensure that EFCE logo is present in all brochures and programs.

Success of speed presentations with excellent timing.

Microphone handling too complex for people questions: it is important to have a person instructed for PC and video/audio system constantly present in each room.

Consider a young session dedicated to young researchers . Perhaps also a course, or school for young people. Possibility of organizing a dedicated PhD poster session to exchange experience.

Consider keynote lectures for revising the topics of future LPS. Possible items of interest for courses: "Engineering ethics" and "Risk communication to public"

Consider ending the symposium with lunch in the last day, instead of having post lunch sessions.

All these items will be further discussed at next "strategic meeting of LPWP.

Evaluation file for Process Safety and Environmental Protection (PSEP) – Loss Prevention Bulletin (LPB) was distributed among LPWP members to be returned to BF appointed guest editor by IChemE, by 30th July.
