5) Final decision on venue for LPS 2022

Following Skype Meeting held on Tuesday 15.1.2019 with the working group and Ales detailed presentation it was selected PRAHA (CZ) as the venue for LPS 2022. www.lossprevention2022.org

6) LP 2019 Program review incl. special sessions, roundtables & latest changes

The review team of the 4^{th} EFCE Process Safety Excellence Award: A. Laurent , G. Reniers, T. Meyer, A. Jacobsson, L. Jelemensky, H.J. Pasman, R. Harbers and B. Fabiano selected Dr. Paolo Mocellin (Padova University, Italy) as the winner for his PhD thesis "CCS and EOR hazard analysis. Experimental Investigation and Modelling of Multiphase Pressurized CO_2 Releases".

It was observed an increased number of submitted candidates from different Countries and that all the four candidates were characterized by outstanding scientific and academic profiles. Sponsor: ASPEN OSS B.V.

LP2019 Review general status

BF presented a statistical trend including last figure provided by GR:

GR leaded following points reporting all relevant updates.

At the opening of the Symposium 406 delegates are officially registered. It was felt by the committee that this was a good number of delegates for the Symposium and all congratulated with GR for the effective work done. As a warning for future date selection, BF evidenced that in the same days and in the same Country of LPS2019, the 29th European Symposium on Computer-Aided process Engineering ESCAPE-29 will take place. Several delegates interested in both Symposium topics were obliged to select one event only.

According to the survey conducted during the online registration to LPS 2019, nearly 70% of participants indicated a preference of 3-year frequency for the Loss Prevention Symposium. After discussion, the committee decided to confirm the traditional 3 year-frequency of LPS. GR reported that the publication of LP2019 papers on CET journal requires a strict and rigid format and that the publisher does not provide support for correcting the papers not properly formatted. In this regard, it is decided to send to all authors an e-mail asking them to verify the correct format of their paper and to send the final revision of their paper to LP2019 secretary within 15 July.

For future LPS events it is suggested to make agreement with the handling publisher to include in the publishing fees also format verification and revision and the whole editorial process until final publication.
